TEST SITE

WC/WCX Tests will be held at Delaware State Park, Delaware, Ohio

The tests will be held at the Delaware, OH Natural Wildlife Area, which is about 8 miles north of Delaware Ohio. Take State Route 23 to State Route 229. Turn East onto 229 and follow about 1.5 miles to the entrance to the area. Follow signs to the test site.

WC/WCX TEST REGULATIONS;

Copies of the complete WC/WCX requirements will be at the Test headquarters. Gun handling is not required of the handler. The handler for the WC/WCX may wear white clothing. Arrive on time in order to hear the judge's instructions to the handlers. Dogs will be judged in catalog order, unless otherwise requested by the judges. BITCHES IN SEASON ARE NOT ALLOWED ON THE TEST GROUNDS.

WC/WCX Scratches:

Refunds will be made for sickness, injury, death, or bitches in season upon receiving a note from a veterinarian.
